Food processing industry is growing at the rate of 7% and is expected to grow from US\$ 200 billion in 2008 to US\$ 310 billion in 2015 with highest growth in the fruits and vegetables sector (20%).

Fruit & Vegetable processing in India is just 2 - 3% while it is 23% in China and 60 - 65% in other countries

All common services like water, CETP, Power Substation have been commissioned. CETP is currently setup to handle Fruit and Vegetables.

Srini food Park is an ISO 22000:2005 company having FSSAI and SGF registrations and is in advanced stages of implementation for USFDA and Kocher certifications. We are a one stop shop for your requirement for Fruit Pulp, Concentrates, Frozen Pulp, IQF Dices and Tetrapak Juices.

- 1. Sourcing of Pulp requirement from Srini Food Park Multi Fruit processing line stored in covered warehouses.
 - Concentrate (6 MT/Hr) & Pulp/Puree (10 MT/Hr) (Mango, Papaya, Banana and Guava)
 - o Tomato Paste (2 MT/Hr) Hot or Cold Break at 28 Brix
 - o Mango Ripening Chambers 14 no's of 200 MT capacity each
 - o Banana Ripening Chambers 4 No's of 20 MT capacity each



2. IQF and Blast Freezer.

- 6 mm and 10 mm plus Mango, Papaya, and Guava Dices
- Frozen Pulp
- IQF with 2 MT/Hr capacity from Starfrost UK and Urschel Dicer

3. 200 ml Slim pack Tetrapak filler and processing for fruit juices

- 5) Common Facilities like RO and Soft Water, Central Effluent Treatment Plant, Power, Street Lighting, Security and Weigh Bridges.
- 6) Integrated Pack Houses with VHT facilities at Nuzvid and Tirupathi with Cold Chain (Cold Stores) supported by Collection Centers across four districts for sourcing of quality raw produce



- 7) Right on the NH-4 at 150 KM to Bangalore and 160 KM to Chennai, the highway is currently under conversion to six lane expressway.
- 8) State of Art Testing Laboratory in the premises.

- AP State 2010 GO # 95 issued which provides 75% VAT reimbursement for all units in Food Park for 5 Years and Stamp Duty reimbursement.
- AP State policy of Rs. 1.00 per Unit reimbursement for Power consumed for 5 Years. Per Unit rate of power in AP currently in Rs. 3.75, so effective rate will come down to Rs. 2.75 per Unit of power.
- GOI Policy waives Corporate Income Tax for 5 Year period from commissioning date.
