Bust or Chest Measure over the fullest part of the chest under the arms and straight across the back.

Waist Measure around the natural waistline - with tape snug but not tight.

Hips/Seat Measure the fullest part of the body, generally 20cm below the waist.

Inside Leg Measure from crutch to floor: what is your normal inside leg measurement?

GARMENT CARE

Always read the label before laundering

Wash new and dark coloured clothing before wearing to prevent any colour migration on to other garments or under clothing

To prevent staining, wash dark coloured garments separate to white colours.

Garments should be washed regularly to prevent a build up of soil, which can prove hard to remove.

Using fabric softeners and conditioners can be detrimental to the performance of garments as their effect can actually lead to faster fabric abrasion.

Avoid tumble drying if possible as this can lead to shrinkage or damage, due to temperatures not being regulated.

Ironing garments whilst they are still damp does improve crease removal.

TERMS AND CONDITIONS

This document (together with the documents referred to on it) tells you the terms and conditions on which we supply to you any of the products ("Products") listed in this catalogue ("Catalogue"). Please read these terms and conditions carefully before ordering any Products from the Catalogue. You should understand that by ordering any of our Products, you agree to be bound by these terms and conditions. These terms and conditions relate to trade sales only and not consumer sales.

1 INFORMATION ABOUT US

1.1 Products in this Catalogue are offered by Grabal Alok (UK) Limited trading as Uniforms Twenty One ("we"). We are registered in England and Wales under company number 04246489 and with our registered office at Tureck House, Drayton Road, Shirley, Solihull B90 4NG (which is also our main trading address). Our VAT number is 927 5062 19.

1.2 We are a limited company.

2 YOUR STATUS

2.1 By placing an order with us, you warrant that: a) You are legally capable of entering into binding contracts, b) you are placing that order on behalf of a business and not as a consumer and c) you have authority to place that order.

3 HOW THE CONTRACT IS FORMED BETWEEN YOU AND US

3.1 After placing an order, you will receive an e-mail from us acknowledging that we have received your order. Please note that this does not mean that your order has been accepted. Your order constitutes your offer to us to buy our Products). All orders are subject to acceptance by us, and we will confirm such acceptance to you by sending you an e-mail that confirms that the Product has been dispatched (the "Dispatch Confirmation"). The contract between us ("Contract") will only be formed when we send you the Dispatch Confirmation.

3.2 The Contract will relate only to those Products whose dispatch we have confirmed in the Dispatch Confirmation. We will not be obliged to supply any other Products which may have been part of your order until the dispatch of such Products has been confirmed in a separate Dispatch Confirmation.

3.3 The terms of the Contract comprise these terms and condition and the specific details (Product, price, etc.) set out in the Dispatch Confirmation. Any terms specifically agreed between us that are in addition to these Terms and Conditions will only be incorporated into the Contract if such terms are in writing and signed by one of our Directors.

3.4 It is your responsibility to ensure that the terms of your order are complete and accurate.

3.5 Save as set out in the Contract, these Terms and Conditions may only be varied or amended in writing and signed by one of our Directors.

4 THE PRODUCTS

4.1 The quality and description of the Products will be as per the appropriate latest samples ("Samples") provided by us, if any.

4.2 Any Samples will be invoiced to you as they are dispatched. The cost of the Samples will be credited back to your account once they have been returned to us, unworn and unused and within 30 days of our invoice. If for any reason, you do not return the Samples to us then the cost, including any post, packaging and VAT will be immediately payable.

4.3 We may make any changes to the specification, design, materials or finishes of the Products which:

4.3.1 are required to conform with any applicable safety or other statutory or regulatory requirements; or

4.3.2 do not materially affect their appearance, quality or performance.

5 AVAILABILITY AND DELIVERY

5.1 Time shall not be of the essence with regard to delivery and any delivery date set out in the Dispatch Confirmation, or elsewhere, are estimates only.

5.2 Delivery shall take place at the premises set out in the Dispatch Confirmation.

5.3 If you do not accept delivery of the Products or we are unable to deliver the Products due to any act or omission on your part, risk in those Products will pass to you and you will be liable for any and all additional costs incurred including, but not limited to, those arising from storage and repeated delivery.

5.4 We may deliver the Products by separate installments. Each separate installment will be invoiced and paid for in accordance with the provisions of the Contract.

5.5 Each installment will be a separate Contract and no cancellation or termination of any one Contract relating to an installment will entitle you to reject, repudiate or cancel any other Contract or installment or withhold payment for any other Contract or installment.

5.6 Any claims relating to non-delivery or any damage to Products in transit, which is reasonably discoverable on inspection, must be made by you within 10 days of the date of our invoice. Our liability in relation to this clause shall be limited to replacement of the Products or refund of the purchase price.

6 CANCELLATION AND RETURNS

6.1 Orders placed for Catalogue Products (i.e. not bespoke or personalised garments) can be cancelled any time up to 2 weeks before the date of delivery but you will be charged for any costs that have been incurred in the manufacture up to the point your written notification of cancellation was received by us.

6.2 Personalised, bespoke, altered or non-catalogue style garments cannot be cancelled.

6.3 We are happy to replace or refund any Products from our Catalogue provided that you enclose a letter with the return detailing the invoice number, and the reason for the return. The refund will be made provided that the Products are returned to us unworn within 7 days of delivery. We reserve the right to deduct a handling fee from the refund payment.

7 RISK AND TITLE

7.1 Subject to clause 5.3, the Products will be at your risk from the time of delivery.

7.2 Ownership of the Products will only pass to you when we receive full payment of all sums due in respect of the Products, including delivery charges.

7.3 Until ownership of the Products has passed to you, you must hold the Products on a fiduciary basis as our bailee.

7.4 Your right to possession of the Products will terminate immediately if any of the circumstances of condition 15.1 occur.

7.5 We will be entitled to recover payment for the Products notwithstanding that title in any of the Products has not passed from us.

7.6 You grant us, our agents and employees an irrevocable licence at any time to enter any premises where the Products are or may be stored in order to inspect them, or, where your right to possession has terminated, to recover them.

7.7 On termination of the Contract, howsoever caused, your rights to possession of the Products that have not been paid for will cease however, our rights contained in this Condition 7 will remain in effect.

8 PRICE AND PAYMENT

8.1 The price of any Products will be as quoted in this Catalogue, except in cases of obvious error.

8.2 All prices quoted are exclusive of VAT, postage and packaging.

8.3 Any further services such as embroidery, personalisation, or alterations to the Products will incur further charges. These charges will be agreed between us before you place your order with us.

8.4 Prices are liable to change at any time, but changes will not affect orders in respect of which we have already sent you a Dispatch Confirmation.

8.5 Payment must be paid by you within 30 days of the date of our invoice.

8.6 Without prejudice to our other rights, your failure to pay any invoice in accordance with condition 8.5 above may at our discretion lead to one of the following:

8.6.1 the suspension or cancellation of any discounts that we have applied to your order; and/or

8.6.2 suspension or cancellation of any future deliveries.

8.7 All payments shall be made without any deduction whether by way of set off, counterclaim, discount, abatement or otherwise.

8.8 Time for payment shall be of the essence and no payment shall be deemed to have been received until we have received cleared funds.

8.9 If you fail to pay us any sum due you will be liable to pay interest to us on such sum from the due date for payment at the annual rate of 3% above the base lending rate from time to time of National Westminster Bank plc accruing on a daily basis until payment is made, whether before or after any judgment.

8.10 If your payment of any invoice is delayed by more than 45 days we reserve the right to charge you an administration fee.

8.11 All sums payable to us under the Contract will become due immediately upon termination of the Contract.

9 OUR LIABILITY

9.1 We warrant to you that any Product purchased from us via our Catalogue is of satisfactory quality within the meaning of the Sale of Goods Act 1979.

9.2 The zips, fastenings, seams and materials in our Products are guaranteed for a period of 24 months from the date of purchase. This guarantee is subject to the following conditions:

9.2.1 we will not be responsible for defects which occur due to reasons other than fair wear and tear, or to your negligence or failure to follow the correct care instructions, alteration or misuse or use in abnormal working conditions;

9.2.2 full payment for the Products in accordance with condition 8.5.

9.2.3 if the reason for the defect is the design, drawing or specification, which you have provided to us.

9.3 All warranties, conditions and other terms implied by statute or common law are to the fullest extent permitted by law, excluded from the Contract.

9.4 Our liability for losses you suffer as a result of us breaking this agreement is strictly limited to the price paid for the Product you purchased.

9.5 If any Products do not conform with the warranty at condition 9.1 we shall at our sole discretion repair or replace such Products (or the defective part) or refund the price of such Products provided that if we so request you shall return the Products to us at your expense and we shall have no further liability for a breach of the warranty at 9.1 in respect of such Products.

9.6 We shall not be liable for a breach of the warranty in condition 9.1 unless you give us written notice of the defect within 7 days of the time when you discover the defect or ought to have discovered the defect.

9.7 We will endeavour to match colours in printing designs and logos onto the Products but no warranty is given in respect of this.

9.8 We are not responsible for indirect losses which happen as a side effect of the main loss or damage, including but not limited to: a) loss of income or revenue; b) loss of business; c) loss of profits or contracts; d) loss of anticipated savings; e) loss of data; or f) waste of management or office time however arising and whether caused by tort (including negligence), breach of contract or otherwise, even if foreseeable.

9.9 These Terms and Conditions of Supply shall not limit in any way our liability:

9.9.1 for death or personal injury caused by our negligence;

9.9.2 for fraud or fraudulent misrepresentation; or

9.9.3 for any matter for which it would be illegal for us to exclude, or attempt to exclude, our liability.

10 INDEMNITY

10.1 You shall indemnify us against all loss (including loss of profit) or expense however indirect or remote resulting from cancellation or other breach of the Contract by you.

11 DATA PROTECTION ACT 1998

11.1 In compliance with the Data Protection Act 1998, customers operating as a partnership or sole trader are hereby given notice that we may transfer information about you to our bankers/financiers for the purposes of supplying the Products and for the following purposes:

11.2 obtaining credit insurance;

11.3 making credit reference agency searches;

11.4 credit control;

11.5 assessment and analysis (including credit scoring, market, product and statistical analysis);

11.6 securitisation; and

11.7 protecting our interests.

11.8 We will provide you with details of our bankers/financiers and that of any credit reference agencies used on request.

12 WRITTEN COMMUNICATIONS

12.1 Applicable laws require that some of the information or communications we send to you should be in writing. When using our Catalogue, you accept that communication with us may be either by electronic mail or by post. For contractual purposes, you agree that either method of communication is acceptable you acknowledge that all contracts, notices, information and other communications that we provide to you electronically comply with any legal requirement that such communications be in writing. This condition does not affect your statutory rights.

13 NOTICES

13.1 All notices given by you to us must be given to Grabal Alok (UK) Limited at info@uniformstwentynone.co.uk. We may give notice to you at either the e-mail or postal address you provide to us when placing an order, or in any of the ways specified in condition 12 above. Notice will be deemed received and properly served 24 hours after an e-mail is sent, or three days after the date of posting of any letter. In proving the service of any notice, it will be sufficient to prove, in the case of a letter, that such letter was properly addressed, stamped and placed in the post and, in the case of an e-mail that such e-mail was sent to the specified e-mail address of the addressee. We will not be liable for any timeframes under this contract unless the notice you send to us by email is also sent to us by facsimile transmission to 0121 703 8981 on the same day as the day the email was sent.

14 TRANSFER OF RIGHTS AND OBLIGATIONS

14.1 The Contract is binding on you and us and on our respective successors and assigns.

14.2 You may not transfer, assign, charge or otherwise dispose of a Contract, or any of your rights or obligations arising under it, without our prior written consent.

14.3 We may transfer, assign, charge, sub-contract or otherwise dispose of a Contract, or any of our rights or obligations arising under it, at any time during the term of the Contract.

15 TERMINATION

15.1 We may by notice to you terminate the Contract immediately if you:

15.1.1 are in material breach of any of the terms of the Contract and the breach is incapable of remedy. Failure to pay any sums due in accordance with condition 8 is a material breach of the terms of the Contract which is not capable of remedy.

15.1.2 are in material breach of any of the terms of the Contract where the breach is capable of remedy and you fail to remedy such breach within 15 days following service of a written notice from us, specifying the breach and requiring it to be remedied;

15.1.3 become bankrupt, insolvent, make any composition with your creditors, have a receiver appointed under the Mental Health Act 1983 or die;

15.1.4 have any distraint, execution or other process levied or enforced on any of its property;

15.1.5 cease to trade or appear in our reasonable opinion likely to or are threatening to cease to trade;

15.1.6 are subject to a term of imprisonment whether or not suspended;

15.1.7 have a change in your management and/or control as defined by section 840 Income and Corporation Taxes Act 1988; or

15.1.8 the equivalent of any of the above occurs to you under the jurisdiction to which the you are subject or we reasonably anticipate that one of the above set of circumstances is about to occur.

15.2 The termination of the Contract howsoever arising is without prejudice to any of our rights, duties and/or liabilities that have accrued prior to termination. The conditions which expressly or impliedly have effect after termination will continue to be enforceable notwithstanding termination.

15.3 We will be entitled to suspend any deliveries otherwise due to occur following service of a notice specifying breach under 15.1.2, until either you have remedied the breach or the Contract terminates, whichever occurs first.

16 EVENTS OUTSIDE OUR CONTROL

16.1 We will not be liable or responsible for any failure to perform, or delay in performance of, any of our obligations under a Contract that is caused by a Force Majeure Event as defined below.

16.2 A Force Majeure Event includes any act, event, non-happening, omission or accident beyond our reasonable control and includes in particular (without limitation) the following:

16.2.1 Strikes, lock-outs or other industrial action.

16.2.2 Civil commotion, riot, invasion, terrorist attack or threat of terrorist attack, war (whether declared or not) or threat or preparation for war.

16.2.3 Fire, explosion, storm, flood, earthquake, subsidence, epidemic or other natural disaster.

16.2.4 Impossibility of the use of railways, shipping, aircraft, motor transport or other means of public or private transport.

16.2.5 Impossibility of the use of public or private telecommunications networks.

16.2.6 The acts, decrees, legislation, regulations or restrictions of any government.

16.3 Our performance under any Contract is deemed to be suspended for the period that the Force Majeure Event continues, and we will have an extension of time for performance for the duration of that period. We will use our reasonable endeavours to bring the Force Majeure Event to a close or to find a solution by which our obligations under the Contract may be performed despite the Force Majeure Event.

16.4 If the Force Majeure Event continues for a period of more than three months then either party may cancel the Contract without penalty by providing written notification to the other.

17 WAIVER

17.1 If we fail, at any time during the term of a Contract, to insist upon strict performance of any of your obligations under the Contract or any of these terms and conditions, or if we fail to exercise any of the rights or remedies to which we are entitled under the Contract, this shall not constitute a waiver of such rights or remedies and shall not relieve you from compliance with such obligations.

17.2 A waiver by us of any default shall not constitute a waiver of any subsequent default.

17.3 No waiver by us of any of these terms and conditions shall be effective unless it is expressly stated to be a waiver and is communicated to you in writing in accordance with condition 14.

18 SEVERABILITY

18.1 If any of these terms and conditions or any provisions of a Contract are determined by any competent authority to be invalid, unlawful or unenforceable to any extent, such term, condition or provision will to that extent be severed from the remaining terms, conditions and provisions which will continue to be valid to the fullest extent permitted by law.

19 ENTIRE AGREEMENT

19.1 These terms and conditions the Dispatch Confirmation represent the entire agreement between us in relation to the subject matter of any Contract and supersede any prior agreement, understanding or arrangement between us, whether oral or in writing.

19.2 We each acknowledge that, in entering into a Contract, neither of us has relied on any representation, undertaking or promise given by the other or be implied from anything said or written in negotiations between us prior to such Contract except as expressly stated in these terms and conditions.

19.3 You shall not have any remedy in respect of any untrue statement made by us, whether orally or in writing, prior to the date of any Contract (unless such untrue statement was made fraudulently) and your only remedy shall be for breach of contract as provided in these terms and conditions.

19.4 All illustrations and specifications relating to the Products are approximate only and we reserve the right to make such alterations as we think fit.

Performance figures are approximate and not to be relied on.

20 OUR RIGHT TO VARY THESE TERMS AND CONDITIONS

20.1 We have the right to revise and amend these terms and conditions from time to time.

20.2 You will be subject to the policies and terms and conditions in force at the time that you order Products from us, unless any change to those policies or these terms and conditions is required to be made by law or governmental authority (in which case it will apply to orders previously placed by you), or if we notify you of the change to those policies or these terms and conditions before we send you the Dispatch Confirmation (in which case we have the right to assume that you have accepted the change to the terms and conditions, unless you notify us to the contrary within seven working days of receipt by you of the Products).

21 LAW AND JURISDICTION

21.1 Contracts for the purchase of Products via this Catalogue will be governed by English law. Any dispute arising from, or related to, such Contracts shall be subject to the exclusive jurisdiction of the courts of England and Wales.
